

The Quorum Court of Crawford County, Arkansas met March 18, 2019, for the third regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4th Street, Van Buren, Arkansas. Crawford County Judge Gilstrap presiding. Jacob Howell, Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present were Justices Roger Atwell, Lloyd Cole, Cox, Decroo, Damante, Harvey, Johnson, Myers, Peppas, Perry, Shaffer, Wahlmeier and Woodruff.

The minutes of the last regular meeting and reports were presented. County Judge Gilstrap wanted to make a correction to the February 19, 2019 minutes where it stated Ordinance 2019-6 <u>failed</u> but instead it should read <u>tabled</u>. Justice Peppas moved to approve as amended and second by Justice Perry and unanimous voice vote the minutes and reports were approved as amended and written.

The minutes of the budget committee meetings, Justice Harvey made the motion to approve, second by Justice Woodruff.

COMMITTEE REPORTS: Justice Harvey stated that in the past a company that has visited us a few times are coming back in April, they are bringing all their executives with them at this time even a couple of manufactures. Maybe by the April Quorum Court meeting we may have more exciting news to be able to announce these corporations.

JUDGES NOTE: (1) County Judge Gilstrap presented Justice Chase Decroo with a plaque "Crawford County Special Recognition" for his quick thinking while not on duty to help assist an Oklahoma Highway Patrolman that was having a difficult struggle with a suspect that had been pulled over. The Personnel Committee meeting began at 6:10 PM on 3/18/2019 with Justice Roger Atwell as

Chairman. The following JPs were present:

- 1. Treasurer Beverly Pyle reported unapproved turn back funds have been added to provide a total in General Fund of \$415,050 and Public Safety \$66,833.
- 2. Pyle also reminded the court that during the even years there are 27 pay role periods as opposed to 26 in the odd numbered years. This means an additional total of \$308,000 will be needed during the year 2020.

- 3. Justice Chase Decroo joined the Committee meeting at 6:35 as discussion began concerning the request for additional full-time employee for the VA Representatives office. After much discussion Justice Damante proposed funding for part-time employee to continue through the 2019 year. Vote was 9 in favor and 3 against.
- 4. County Coroner Pam Wells reported increased calls and requested an additional full-time employee. She is the only full-time staff member and has 3 part-time Deputies. Lloyd Cole proposed funding \$20,000 from General Fund to assist in her increased caseload. 12 voted in favor and zero against.
- 5. Meeting was halted until after the scheduled monthly Quorum Court meeting.
- 6. As the Personnel Committee resumed with all JPs present the County Sheriff discussed the need for a full-time Maintenance position and the addition of a Deputy position. Funding would be provided by a portion of the 1/4/percent sales tax that is currently used for jail operation. Both positions were approved 13-0.
- Representative of the Prosecutor reminded the court that a request was submitted for an additional staff member in 2015. The position was approved but funding has not yet been provided. Prosecutor wants the court to know that the need for an addition employee still exists.



2019 Budget

Our office wants to thank those of you who voted for giving our Veterans Service Officer a part time position.

It has been brought to our attention by the chief deputy in the County Clerk's office that in the courthouse, there are only two part time positions in the system at this time, including ours, three with the new part time Coroner position also created at the March Quorum Court meeting. In Ordinance 2018-35 dated 12-17-18, the Quorum Court voted to discontinue the Oliver Pay Study and adopt the pay schedule presently being used by the County payroll. She suggested that we come to you and ask that all the part time positions be paid the same, to simplify things in their office and to be certain there is no discrimination in part time positions. Our clerk is currently being paid \$10.00 per hour for 20 hours per week. The part time position in the Assessor's office that was adopted in the above ordinance as the pay schedule for part time that is currently being used is being paid \$11.00 per hour at 29 hours per week.

So, with that being said, we are coming before you asking that our part time position that was created in the March Quorum Court meeting, be paid the current rate of \$11.00. and have the same part time hours of 29 to keep all part time positions the same with no discrimination. The break down for additional money needed to make it equal to the one part time position that was adopted in the above reference ordinance is listed below.



I would like to thank you for approving a part-time position for a Chief Deputy Coroner at the last meeting. However, it is imperative that this position be full-time. Chief Edwards has already worked well over 40 hours this past week because of our call demand.

In addition to the daily operations of the Forensic Center, The Coroner's Office has worked five crime scenes in the last 5 days, which require more than one person and numerous hours and days to complete. We are also transporting more and more decedents in which the family has not been able to tell us or decide on a funeral home. As of this date, we have worked 111 deaths for the year. The Coroner's Office cannot continue to operate without this position.

This is the difference in the full time salary of \$14,044.23 and the \$20,000.00 approved at the last meeting to make this a full time Chief Deputy salary till the end of the year.
