QUORUM COURT JOURNAL OF PROCEEDINGS

The Quorum Court of Crawford County, Arkansas met May 20, 2019, for the fifth regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4th Street, Van Buren, Arkansas. Crawford County Judge Gilstrap presiding. Jacob Howell, Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present were Justices Roger Atwell, Lloyd Cole, Cox, Decroo, Damante, Harvey, Johnson, Myers, Peppas, Perry, Wahlmeier and Woodruff. Justice Shaffer was absent.

The minutes of the last regular meeting and reports were presented. Justice Woodruff moved to approve as amended and second by Justice Decroo and unanimous voice vote the minutes were approved as amended and written.

The minutes of the Budget Committee meetings, Justice Perry made the motion to approve, second by Justice Peppas and unanimous voice vote the minutes were approved.

COMMITTEE REPORTS: (1) Justice Harvey ACT Work Ready program is moving along, second meeting is to follow up on July 26, 2019, hopefully this can be in place for the next school year. (2) Justice Wahlmeier stated that we do get the Quorum Court packet on the internet now, so they are publically available. The packet we get now is on the Crawford County web site.

JUDGES NOTE: (1) Newly appointed Circuit Court Division III Judge Marc McCune addressed the quorum after the Budget Committee meeting stating what he was going to need to set up and furnish the new Circuit Court Division III office. New computers for him, assistant coordinator and court reporter will come with a cost of about \$17,000.00, copy machine will be from \$6,000.00 to \$7,000.00, furniture \$5,000.00. Some of this can be paid out of the Circuit Court Automation Fund. Then we will be needing some funds to set up the office expense such as letterheads, envelopes, paper and other items. We are working on a budget to present to the Quorum Court for the June meeting for the remainder of the year. Also we will need to separate the security cameras and security on the back door from Judge Medlock. This newly created position will take effect July 1, 2019. Some of the building construction for a new office may be able to come out of the bond fortitude money. (2) Judge Gilstrap wanted to congratulate the new Circuit Court Division III Judge Marc McCune who was recently appointed by the governor and this will take effect on July 1, 2019. (3) The lightning strike that hit the courthouse we are still working with the insurance company. The quotes are in and we are well over \$100,000.00. (4) We also have dedicated the new stop light at the intersection of Hwy. #71 North and Hwy. #282 (which was known for the flashing light). Also the new 81 Loop Bridge was dedicated. (5) The road department is on its fourth mile of asphalt. We have been fighting the rain off and on.

They greatly appreciated the county working with them on this matter and they were all satisfied with the correction of the new county road standards that was passed tonight.
