## CRAWFORD COUNTY ARKANSAS

### QUORUM COURT JOURNAL OF PROCEEDINGS

The Quorum Court of Crawford County, Arkansas met August 19, 2019, for the eight regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4<sup>th</sup> Street, Van Buren, Arkansas. Judge Gilstrap presiding. Jacob Howell, Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present were Justices Atwell, Cole, Cox, DeCroy, Damante, Harvey, Johnson, Myers, Peppas Perry, Shaffer, Wahlmeier and Woodruff .

The minutes of the last Regular July meeting and reports were presented. Justice Harvey moved to approve and second by Justice Peppas and unanimous voice vote the minutes and reports were approved as written.

The minutes of the budget committee were presented. Justice Perry moved to approve, second by Justice Harvey. Unanimous voice vote minutes and reports were approved as written.

COMMITTEE REPORTS: (1) Justice Harvey stated that ACT Work Ready Committee had their meeting this morning. Big thing they talked about is to have a Crawford County Career Rodeo, it will be like a job fair. We will try to have it at the county fairgrounds in which we will try to have skilled workforce there, maybe about 25-30 trades like the plumbers, electrical, heavy equipment operators and etc. that can physically talk to them about a specific trade that might be for them. This would be for students that plan on going directly into the work force straight out of high school. The committee would like to schedule this job fair sometime between March and April, 2020. Debbie Faubus-Kendrick stated at the meeting that Sheriff Ron Brown has started giving his trustees an ACT Work Ready test and also a NCRC test, two of these trustees have scored a silver and one of them has since got a job at Pepper Source. At a training prior we had Clarksville and Charleston to attend the meeting, they can see the benefits of getting them into the workforce. (2) APH (American Patriot Holding) that develops ships that can travel our water ways , have since received funding to build these ships, now we just need a couple of other things to fall in place.

JUDGES NOTE: (1) Judge Gilstrap introduced Eric Simpson Crawford County's new Fire Coordinator. (2) The storm that started north of Chester and continued on to Mt. Burg and into Franklin County the state declared our threshold in the amount of about \$234,000.00 in which we will easily meet this amount. We are waiting to hear back from the Arkansas Department of Emergency Management on this situation. We have 19-20 roads that qualify for assistance. Sheriff department started getting calls from Mountainburg about a stranded motorist and then some homes between Mountainburg and Mulberry. District #3 Fire Department and some from the Sheriff office began gathering boats to help with rescue on Graphic Road. Brad Thomas wanted to thank everyone that helped even the Van Buren Police Department. Judge Gilstrap stated on the first disaster with the river flooding, 81 Loop and Parks road washouts this went on into a Federal disaster. We should get reimburse about

75% back on our comp time and the money should go back into the fund it was paid out of. State disaster has about 35% reimbursement.

On motion by Justice Shaffer to amend the agenda and add Resolution No. 2016-6 (to **nominate Jo Wester as the Crawford County Clerk effective August 31, 2019**), seconded by Justice Perry, roll call vote to place Resolution No. 2019-6 on the agenda, 12 yeas, 1 nay. On motion by Justice Shaffer to place Resolution No. 2019-6 on the floor (to **approve Jo Wester as the new Crawford County Clerk effective August 31, 2019**), second by Justice Cole. Resolution No. 2019-6 was presented. After reading in its entirety, Justice Harvey moved to approve, second by Justice Woodruff. There was some discussion by the court, roll call vote 11 yeas, 2 nays.

COMMENTS FROM THE PUBLIC: (1) Judge Gilstrap wanted to remind everyone that the Crawford County Fair would start on September 9 thru 14 at the Mulberry Fairgrounds. (2) Elaine Stanfield also announced that the Trash Pick-up would start on September 21 at Rudy, September 28 Natural Dam, October 5 Cedarville & Turner, October 12 Mountainburg, Chester, Locke, Dyer, October 19 Mulberry & Uniontown. (3) Justice Myers stated that the Mulberry School would be holding a Health & Welfare Clinic on Friday, August 23, 2019 between the hours of 5-7 p.m. (4) Justice Damante also wanted to remind all Justice's to bring their budget books into the County Clerk's office, so they can get the budget books ready for the budget meetings coming up in the fall.
