**QUORUM COURT JOURNAL OF PROCEEDINGS**

The Quorum Court of Crawford County, Arkansas met November 18, 2019, for the eleventh regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4<sup>th</sup> Street, Van Buren, Arkansas. Crawford County Judge Gilstrap presiding. Jacob Howell, Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present were Justices Cole, Cox, DeCoo, Damante, Harvey, Johnson, Myers, Peppas, Perry, Shaffer, Wahlmeier, Woodruff with Justice Atwell absent

The minutes of the last regular meeting and reports were presented. Justice Harvey moved to approve and second by Justice Woodruff and unanimous voice vote the minutes and reports were approved as written.

The minutes of the budget committee meetings, Justice Harvey made the motion to approve, second by Justice Perry were presented and approved as written.

COMMITTEE REPORTS: (1) Justice Harvey, stated that he went to a summit for the ACT Work Ready Program in which city, county leaders were there along with public educators from all across the country. I am going to ask Dennis Williamson to the December or January meeting to give us an update on how this is moving along for 2020. (2) Port: past couple of weeks there has been quite a bit of movement. WAIPA (Western Arkansas Intermodal Port Authority) has reached out to Judge Gilstrap because they are going after an EDA grant for \$450,000.00, it will be an 80/20 grant. This is for funding the engineering of the utilities and any fees we might have for environmental study that is needed to continue moving this project forward. City of Van Buren has stepped up and wants to be a part of this, as far as Sebastian County and the City of Fort Smith I am not aware of their standing on this project.

JUDGES NOTE: (1) Judge Gilstrap stated that the highway department has lost about a week worth of work on Old #12 road, but we are now filling it back up, still on schedule other than the rain. (2) We have started in on our next lease agreement on our graders and we have now just received the four new dump trucks, which were supposed to be delivered by mid – September. (3) Jacob Howell, Deputy Prosecuting Attorney, legal counselor addressed the Quorum Court about a lawsuit (Rural Fire Departments Taxation) that has been filed today against County Judge Gilstrap and the Quorum Court as an institution. I have begun drafting an answer to their attorney. We will report back to you next month. You as a Quorum need not worry about hiring counsel, we have it under control.
