The Quorum Court of Crawford County, Arkansas met October 19, 2020, for the tenth regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4th Street, Van Buren, Arkansas. Judge Gilstrap presiding. Jacob Howell, Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present were Justices Atwell, Cole, Cox, DeCroo, Damante, Johnson, Myers, Peppas Perry, Shaffer, Walhlmeier, Woodruff. Justice Harvey was absent

The minutes of the last Regular September meeting and reports were presented. Justice Peppas moved to approve and second by Justice Perry and unanimous voice vote the minutes and reports were approved as written.

The minutes of the budget committee were presented. Justice Peppas moved to approve, second by Justice Atwell. Unanimous voice vote minutes and reports were approved as written.

COMMITTEE REPORTS:

JUDGES NOTE: (1) Tax deadline was October 15, 2020 all employees have gone above and beyond during the Corvid-19 virus. (2) Crawford County had its 200th birthday on October 18, 2020, we did not get to celebrate it like we would have liked to but we did do a youtube video with all nine mayors and the governor. (3) Crawford County clean-up has been completed with the help of Justice Cox and Elaine Stanfield. (4) Junior livestock auction was a success with the Crawford County Fair this year. (5) Winding down the chip and seal in which Justice Myers commend the road crew for their work in Mulberry area. (6) Silver Bridge on the Crawford/Franklin County line is being taken apart and Mulberry and Ozark are taking a section of the old bridge to add to their parks. Crawford/Franklin are working together on the bridge, engineer almost done with their study of replacing the bridge.

- (4) RESOLUTION No. 2020-5: A RESOLUTION ADOPTED IN FURTERANCE OF THE CARES ACT AND IN RESPONSE TO THE COVID-19 PANDEMIC EMERGENCY. On motion by Justice Shaffer to read by title only, second by Justice Perry, Resolution No. 2020-5 was presented. After reading by title only Justice Woodruff moved to approve, second by Justice Damante. There was no discussion by the court, roll call vote 12 yeas, 1 absent.

- WHEREAS, the purpose of this Ordinance is immediately necessary for preservation of the health, safety and welfare of the inhabitants of the City of Van Buren, Arkansas, and an emergency exists which requires that this Ordinance become immediately effective and in full force and effect; and
- WHEREAS, the City of Van Buren, Arkansas, must have funds for its municipal operations, and can only obtain the requisite funding to continue its current level of services to its citizens by renewing the levy of a 2 mill tax on real and personal property, for the general municipal purpose of the City, and by renewing the levy of a 1.4 mill tax on real and personal property tax for the Van Buren library maintenance purposes.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF VAN BUREN, ARKANSAS, THAT:

- SECTION 1: The rate of all real and personal property taxes in Van Buren, Arkansas, for the year 2020, for general municipal purposes under the authority of Section 4, Article XII, of the Constitution of 1874, of the State of Arkansas, be, and the same is hereby affixed at 2 mills on the dollar of the assessed valuation of all real and personal property subject to taxation in the City of Van Buren, Arkansas, for the year 2020, for general municipal purposes.
- SECTION 2: The rate of all real and personal property taxes in the City of Van Buren, Arkansas, for the year of 2020, for the maintenance of a City Public Library, under the authority of a vote of the people of the City of Van Buren, Arkansas, and the City General Elections held on the 7th day of April, 1942, (1 mill) and the 8th day of November, 1994, (.4 mill), be, and the same is hereby affixed at 1.4 mills on the dollar of the assessed valuation of all real and personal property subject to taxation in the City of Van Buren, Arkansas, for the year 2020, for the library maintenance purposes,

subject to the provisions of Act No. 848 of 1981; the same being "adjustment or rollback of tax rates due to increase in aggregate valuation of taxable property."

SECTION 3:

A Certified Copy of this Ordinance shall be filed in the office of the County Clerk of Crawford County, Arkansas, in order that the Quorum Court of Crawford County, Arkansas, may include the same in the general levy of the year 2020 and cause the same to be extended upon the tax books and collected as required by law.

SECTION 4:

This Ordinance being immediately necessary to obtain revenue to pay expenses of the City Government for the City of Van Buren, Arkansas, and necessary in providing for the immediate preservation of the public peace, health, and safety, an emergency is declared to exist and this Ordinance shall be, take effect, and be in force after its passage and publication.
