Gentry Wahlmeier, legal counselor was present. Roll was called. Members present were Justices Roger Atwell, Lloyd Cole, Cox, Damante, Harvey, Johnson, Myers, Peppas, Perry, Shaffer, Wahlmeier, Woodruff with Justice DeCroo absent.

The minutes of the last regular meeting and reports were presented. Justice Peppas moved to approve and second by Justice Atwell and unanimous voice vote the minutes and reports were approved as written.

The minutes of the budget committee meetings, Justice Perry made the motion to approve, second by Justice Myers.

COMMITTEE REPORTS: Justice Harvey, Career Work Ready program getting off to a good start, we have started social media to let the general public no about this program. One of Justice Myers, one of his staff has stepped up and taken cochairman with me and has really been a blessing.




