



While the Coroner's Office still needs a full time position, I only ask that the Quorum Court appropriate \$10,000.00 from County General to part-time salaries to cover our immediate operating expenses until such a time that we can discuss additional funding in the near future. Our current total number of calls stands at over 150 for this year so far.

I fully understand that due to this historic pandemic, our County has suffered a drastic decrease in tax revenues, which is why I am requesting these funds from County General instead of Public Safety. I am hoping that FEMA will reimburse some of these salaries for essential personnel.
