QUORUM COURT JOURNAL OF PROCEEDINGS

The Quorum Court of Crawford County, Arkansas met July 20, 2020, for the seventh regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4th Street, Van Buren, Arkansas. Judge Gilstrap presiding. Jacob Howell Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present Justices Atwell, Cole, Cox, DeCroo, Harvey, Johnson, Myers, Peppas Perry, Shaffer, Wahlmeier, Woodruff and Justice Damante absent.

The minutes of the June regular meeting and reports were presented. Justice Cox moved to approved and second by Justice Woodruff and unanimous voice vote the minutes and reports were approved as written.

The minutes of the Budget committee of 6/15/2020 were presented. Justice Cox moved to approve, second by Justice Johnson, minutes were approved as written. The minutes of the Personnel committee of 6/25/2020 were presented. Justice Cox moved to approve, second by Justice Peppas, minutes were approved as written.

COMMITTEE REPORTS: (1) Justice Harvey stated that a couple of weeks ago that he and the Judge had a zoom meeting with Matt Pitch, he gave us some hope that there would be some breaking news within 30 to 45 days. They have reached out to a couple of ship builders so as things gain speed one builder couldn't build all the vessels in appropriate amount of time, so they are going to reach out to different contractors. As ports become operational everyone will have one ship. First phase ours will be designed with one port and one ship, it is pretty exciting.

JUDGES NOTE: (1) Judge Gilstrap stated that he has some new numbers on Covid-19, which we have went up today. We are up to 360 accumulative cases since we started here in Crawford County. Active we went down 6 to 103, there has been a trend over the last couple of weeks, and all except one day there is more recovery than accumulative, which is a good sign. We have had three deaths from Covid-19 in Crawford County. (2) Judge Gilstrap stated also that instead of doing two to three miles of solid strips of paving we are trying to cover the county from side to side replacing asphalt where we have had to replace cans. Hopefully in the next couple of months we can do a couple of new projects. (3) Justice Atwell spoke briefly about the end of the month in which the extra \$600.00 of unemployment will cease, which may have a small effect on our tax revenue coming in for the county. (4) Justice Harvey ask how we as a quorum can come together and help her and do we need an ordinance that says how we pay the corners helpers right now there is no ordinance in place. We also got to be sure that we don't continue move in the process that we are moving in. (5) Corner Pam Wells stated there was no money to pay anyone, so you have bankrupt the office, so if I get a call I will have to call Beasley Transport services which is \$125.00 a call. Justice DeCroo stated that with all due respect we (the quorum) did not bankrupt your office you did. Justice Harvey stated that all numbers don't add up and we can't put numbers to stuff but I am just

trying to figure out how we can help because we didn't do this. Corner Pam Wells said she was open for help as well. You are asking one person over the next six months to do it by their selves. Justice Perry ask the corner how she done it last year with less of a budget and more calls. Justice Harvey stated he just wanted to resolve the issue. Justice Cole stated that we don't want to manage your office and don't want to keep arguing over money, but what we are saying you are spending more than Sebastian County which is twice the size and it doesn't make sense so you need to control your budget. Justice Atwell suggested creating subcommittee and report back to personnel. Justice Harvey stated he would reach out next week to the corner and bring back an ideal to report back to the personnel committee.

COMMENTS FROM THE PUBLIC: (1) Elaine Stanfield wanted to remind everyone of the 2020 census and that we were running behind 40% from the previous census in 2010.


