Plan for Quorum Court and Committee Meetings with ten (10) or more people in attendance.

This plan is being submitted to prevent the disruption and prevent interference of Crawford County, Arkansas' government operations. Our wish is to cooperate with the Governor and the Arkansas Department of Health to ensure our necessary meetings continue to be safe as they have been in the past. As we continue to navigate through this pandemic we will continue to monitor and comply with provisions and directives from the Governor and the Arkansas Department of Health as best we can.

Our first meetings that would be covered by this plan are the January 19, 2021 Budget and Quorum Court Meetings. Please respond with approval or concerns of this plan As Soon As Possible. We wish to include this plan with the meetings agendas sent out to those that has a need to attend the meetings. Our intent is that this plan will be enforced for all Crawford County Regular Quorum Court and Committee Meetings until the Governor lifts the state of emergency for the State of Arkansas concerning COVID-19.

- All seating will be arranged to maintain six (6) feet distancing from occupied seat to occupied seat. Household groups may sit together but six (6) feet distance should be maintained between groups.
- The speaker podium will be at least twelve (12) feet from audience members.
- A maximum of fifty (50) persons will be allowed in the meetings at any one time.
- Face coverings are required for all persons present except children under ten (10) years of age are not required but it is strongly encouraged they wear face coverings. Children less than two (2) years of age or less should not wear a facial covering. Those in attendance over the age of six (6) years that presents a document signed by a Medical Doctor stating for medical reasons they should not be required to wear a mask at work would be exempt from the mask requirement. A Face Shield will be provided for those exempted from the mask requirement for medical reasons.

- Signs will be posted at entrances stating to "STOP" and do not visit if you have signs or symptoms of a respiratory infection, a fever cough or sore throat and /or the loss of taste and smell. The signage will also say if you have had a known exposure with someone with COVID-19 in the last 14 days or if you have had a temperature of 100.4 or higher in the last 48 hours you cannot enter the building.
- Everyone entering the building will be screened by Crawford County Sheriffs Department
 Security personnel. Entrance will be denied to anyone with a temperature of 100.4 or higher.
- Hand sanitizer will be made available at the entrance and throughout the meeting area.
- The building, including restrooms, will be sanitized with a mist sanitizer approved by the EPA for use against COVID-19 before and after meetings. All touch points will be wiped down periodically as needed.
- We will continue to encourage the three (3) Ws. Wash your Hands, Wear a Mask and Watch your Distance.

Judge Gilstrap **reconvened** from the **November 16, 2020** Quorum Court regular meeting at 7:00 p.m. and with no further changes to the November 16, 2020 Quorum Court meeting and none heard meeting adjourned at 7:02 p.m. Justice Shaffer moved to approve, second by Justice Atwell.

The Quorum Court of Crawford County, Arkansas met **December 21, 2020**, for the twelfth regular meeting of the year. The meeting was called to order at 7:03 p.m. in the Circuit Courtroom #2, 220 South 4th Street, Van Buren, Arkansas. Crawford County Judge Gilstrap presiding. Jacob Howell, Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present were Justices Atwell, Cole, Cox, DeCroo, Damante, Harvey, Johnson, Myers, Peppas, Shaffer, Wahlmeier. Justice Woodruff absent.

The minutes of the last regular meeting and reports were presented. Justice Atwell moved to approve and second by Justice Peppas and unanimous voice vote the minutes and reports were approved as written.

COMMITTEE REPORTS: (1) Justice Harvey stated exciting things are going on for the port but it is slow. If there is anything you need to know about some of the cities and the industries that are coming in just call me or come by and see me. (2) I am getting to be a part of a new association coming to Crawford County called 100 Families, Sebastian County has had this for a while but is new to Crawford County. Right now we are in the process of identifying 100 families that are in crisis and we are looking at employers in the river valley that will hire these families that are in Crisis and if they do that and we cross our 'T's" and dot our "I's" the state of Arkansas will reimburse the employer for that employees salary. This is a program under the United Way. United Way will be coming to Crawford County in the near future and will be located in Van Buren, Arkansas up by the Pasta Grill on Main Street. (3) Baptist Hospital in Van Buren, Arkansas is adding some extra services. Also the Baptist Hospital is doing some renovations which is being done by some grants.

JUDGES NOTE: (1) Judge Gilstrap stated that we have received the Crawford County Audit with no findings. Justice Damante moved to except the audit, second by Justice Harvey with unanimous voice vote to approve. (2) Amortization on Jail: It was to be paid off in September, 2023 but we have made a \$610,000.00 and \$500,000.00 extra principal payment last year. We are on schedule to pay off September, 2022. Justice Damante moved to approve and has been reviewed, second by Justice Harvey with unanimous voice vote to approve. (3) I have ask to close the courthouse on Wednesday, December 23, 2020 also on Thursday, December 31, 2020 with your approval. Justice Peppas moved to approve, second by Justice Atwell.

Full-time employees will receive \$1,844.55, taxes and benefits will be deducted. Part-time employees will receive \$922.28, taxes and benefits will be deducted. All county employees as of December 28, 2020, will be receiving this hazard pay. Justices declined any amount of hazard pay for themselves and will be exempt from hazard pay. Section 1: Turf Pro USA and Pest Pro USA which is owned by an elected official of Crawford County, Justice of the Peace District #5 Raymond Harvey and T.W.C. Auto Repair Inc. which is partially owned by Tom Collins, employee of Highway Department is hereby authorized to use the services offered by said companies in the County of Crawford.

Section 2: This ordinance being necessary for the financial continuity of the County of Crawford, Arkansas and necessary in providing for the immediate preservation of the public peace, health, and safety, an emergency is declared to exist, and this Ordinance shall take effect and be in force after its passage and approval.






