The Quorum Court of Crawford County, Arkansas met July 19, 2021, for the seventh regular meeting of the year. The meeting was called to order at 7:00 p.m. in the Circuit Courtroom #2, 220 South 4th Street, Van Buren, Arkansas. Judge Gilstrap presiding. Jacob Howell Deputy Prosecuting Attorney, legal counselor was present. Roll was called. Members present Justices Atwell, Carolan, Cox, DeCroo, Harvey, Johnson, Morrison, Myers, Peppas, Shaffer, Wahlmeier, Woodruff with Justice Perry absent.

The minutes of the July Regular meeting of 6/21/2021 and reports were presented. Justice Woodruff moved to approve and second by Justice Peppas and unanimous voice vote the minutes and reports were approved as written.

The minutes of the Budget committee of 6/21/2021 were presented. Justice Peppas moved to approve, second by Justice Wahlmeier, minutes were approved as written.

COMMITTEE REPORTS:

JUDGES NOTE: (1) You have been getting some text messages from me concerning the American Rescue Plan. I have set Mr. Mark Shaffer up as chairman of this committee. We are going to talk about different inputs where we could utilize this fund. I am asking our legal counsel to help guide us with the disbursement of this fund, what is not spent by December 31, 2026 will have to be turn back. (2) Division I Courtroom is moving right along, the floor is going down and it looks like it will be in August sometime before we get back in the courtroom. (3) We are fixing to take bids now on the remainder part of the roof. (4) The 911 consolidation is moving right along. CRAWFORD COUNTY, ARKANSAS ORDINANCE 2021-30

BE IT ENACTED BY THE QUORUM COURT OF CRAWFORD COUNTY, ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE SETTING THE PAY FOR SHERIFF DEPUTIES AND JAILERS.

Whereas, pursuant to Federal Fair Labor Standards Act, certain law enforcement officers or employees are not required to be compensated monetarily for time worked beyond 160 hours in a 28-day period.

Whereas, though not required, it is permissible to compensate monetarily for said time.

SECTION 1. Sheriff Deputies and Jailers shall be paid that employee's hourly wage for hours worked between 160-171 hours in any 28 day pay period. This shall apply only to those Deputies and Jailers that meet the qualifications set out in the Fair Labor Standards Act.

SECTION 2. If any provision of this Ordinance is held invalid, such invalidity shall not affect other provisions of the ordinance that can be given effect without the invalid provision, and to this end, the provisions of the Ordinance are declared to be severable.

SECTION 3. This Ordinance shall be in effect beginning the first day of the next 28-day pay period.

Crawford County Ordinance No. 2021-31

Be It Ordained By the Quorum Court of Crawford County, State of Arkansas:

An Ordinance to Establish a Special Revenue Fund to be named the County Library ARP Fund; and to Declare an Emergency.

Article 1. <u>Affirmation</u>. It comes before this Court that there is a need to establish a special revenue fund on the books of the county to track the revenues and expenditures of federal assistance through the American Rescue Plan Act for the county library. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws and guidance from the U.S. Treasury.

Article 2. <u>Establishment of Fund</u>. There is hereby created on the books of the Crawford County Treasurer and the books of the Crawford County Clerk or Comptroller a special revenue fund to be known as the County Library ARP Fund with a fund number of 3047 as assigned by Arkansas Legislative Audit. The revenue code for the federal assistance through the ARP Act, as assigned by Legislative Audit, is 7112 – Federal Coronavirus Relief.

Article 3. Operation of Fund. The County Library ARP Fund is subject to the county budgeting, appropriation and expenditure regulations of Arkansas Code Annotated, Title 14; the claims process for county libraries pursuant to § 13-2-404(c)(1)(2); and the County Financial Management System implemented in accordance with § 14-21-101. Funds must be used in accordance with guidelines issued by the U.S. Treasury concerning the legal expenditures of revenues received pursuant to the American Rescue Plan Act of 2021 (P.L. 11-2) and in compliance with the official award notification for grants and cooperative agreements with the Arkansas State Library pursuant to the county library's application for ARP funds. Proper records and documentation must be maintained for audit purposes.

Article 4. <u>Emergency Clause</u>. It is found by this Court that the deposit of federal assistance funds from the American Rescue Plan Act are imminent making it necessary to establish the County Library ARP Fund in order to be able to properly track the revenue and appropriated expenditures. Therefore, an emergency is declared to exist and this ordinance shall be in full force and effect from the date of passage and approval.
