(4) Finally making progress with weather permitting on Old Rouw Road to be able to hard surface it in the spring. We received State Aid which will allow us to do 1.6 miles of Old Uniontown Road, from Hwy. 59 to Pine Hollow Road. This will be an overlay. (5) Just recently we did an agreement with Wave Rural Connect, which is in the Cedarville area and also, we have done an agreement in Mulberry with Windstream. (6) We now have the North Rudy Road drainage project which is about half completed, which is also being done from a grant.






