QUORUM COURT JOURNAL OF PROCEDURES

APRIL 18, 2022

The Quorum Court of Crawford County, Arkansas met April 18, 2022, for the fourth regular meeting of the year. The meeting was held at 7:00 p.m in the Circuit Courtroom II, 220 South 4th St., Van Buren, Arkansas. Judge Gilstrap presiding. Gentry Wahlmeier, Prosecuting Attorney legal counsel was present. Roll was called. Members present were Justice Atwell, Carolan, Harvey, Johnson, Morrison, Myers, Peppas, Perry, Pinkerton, Shaffer, Wahlmeier, Woodruff, absent was Justice Decroo.

The minutes of 3/21/2022 Regular meeting was presented. Justice Peppas moved to approve, second by Justice Woodruff and unanimous voice vote to approve as written.

The minutes of the 3/21/2022 budget meeting was presented. Justice Peppas moved to approve, second by Justice Morrison and unanimous voice vote to approve as written.

REPORTS: Justice Peppas moved to approve, second by Justice Perry and unanimous voice vote to approve all reports as written.

COMMITTEE REPORTS: Justice Harvey stated that the Judge Gilstrap and Chris Keith and himself attend a meeting with Western Arkansas Intermodal Authority on Wednesday, April 6, 2022. Tim Pickering with the office of Ports & Waterways Planning told board members federal grant funds could be available to help purchase land for the intermodal port. New vessels are being developed to transport the containers on inland waterways. Mathew Pitsch said he thinks work on the project could be underway in a year and a half to two years.

COMMENTS FROM THE PUBLIC:

JUDGES NOTES: (1) Judge Gilstrap stated that there was two positions that have come up for renewal Jim White and Blake Rogers has agreed and willing to serve another term on the Equalization Board. I would like to nominate them, Justice Atwell made the motion to except the nomination, second by Justice Myers, unanimous voice vote to approve the nominations. (2) I would like to announce that as of May 2, 2022, Brad Thomas will be come a state employee. He will be working with the Arkansas Department of Emergency Management as the district manager and will be replacing Tim Gehring who is now the Northwest Area Manager who is retiring. (3) Old Uniontown is getting repaved for a 1.6 mile starting at Hwy. 59 to Pine Hollow Road. (4) Still working on the Diamond Center, also Old Rowe Road, and the drainage project on North Rudy Road. (5) It looks like it will be this fall before we will get started on the old bridge that separates Franklin and Crawford County.
