BE IT ENACTED BY THE QUORUM COURT OF CRAWFORD COUNTY, ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO ESTABLISH PREMIUM PAY AND TO AMEND THE ANNUAL OPERATING BUDGET FOR THE CALENDAR YEAR 2022, MAKE ADDITIONAL APPROPRIATIONS, AND FOR OTHER PURPOSES, PREMIUM PAY INCENTIVE FOR ALL ELIGIBLE ESSENTIAL EMPLOYEES WHO WORKED DURING THE TIME PERIOD OF MAY 1, 2022, TO NOVEMBER 30, 2022; A TRANSFER OF \$936,416.55 FROM AMERICAN RESCUE PLAN FUND #3046 TO THE ARPA REVENUE REPLACEMENT FUND #1006 PURSUANT TO CRAWFORD COUNTY ORDINANCE 2022-53.

# BACKGROUND:

ARTICLE 1. WHEREAS, the American Rescue Plan, Public Law No. 117-2 (March 11, 2021) was adopted into law and provided States, Cities, Counties and Tribal Governments Funds for the purpose of addressing the various adverse impacts of Covid-19 upone these governmental units and society, including premium pay for essential workers defined by Interim Final Rule definitions, in pertinent part, as any work performed by a county employee involving regular in-person interactions or regular physical handling of items that were also handled by others:

ARTICLE 2. WHEREAS, 31 C.F.R. Part 35, the US Treasury Interim Final Rule, sets forth the authority and need for providing premium pay to assure the retention and support for essential workers and public functions;

ARTICLE 3. WHEREAS, the Quorum Court of Crawford County recognizes the need to provide resilience to our local government and provide premium pay to our County Employees as authorized by the American Rescue Plan and guidance by the United States Treasury;

# NOW THEREFORE. BE IT ORDAINED AS FOLLOWS:

ARTICLE 4. THEREFORE, the Quorum Court of Crawford County, hereby approves premium pay for eligible county employees employed by the county during the period of May 1, 2022, to November 30, 2022, and have continued their employment with Crawford County through November 30, 2022. In order to be eligible, or qualified, for premium pay, employees shall work at least 7 months, physically in the office, from May 1, 2022 through November 30, 2022. Pursuant to American Rescue Plan guidelines, those who use vacation time, sick time, compensatory time or worked from home for that time duration do not qualify for premium pay.

Each full time and part time Crawford County employee, eligible under the above terms, shall be provided premium pay for that time period and, from which all applicable payroll deductions shall be deducted.

# The amounts payable are as follows:

# Full Time employees who were employed:

- May 1, 2022, through November 30, 2022, will receive \$5,000.00 gross pay;
- June 1, 2022, through November 30, 2022, will receive \$4,000.00 gross pay;
- July 1, 2022, through November 30, 2022, will receive \$3,000.00 gross pay;
- August 1, 2022, through November 30, 2022 will receive \$2,000.00 gross pay;
- September 1, 2022, through November 30, 2022, will receive \$1,000,00 gross pay; and
- October 1, 2022, through November 30, 2022, will not receive premium pay \$B.

#### AND

# Part Time employees who were employed:

- May 1, 2022, Ihrough November 30, 2022, will receive \$2,500.00 gross pay:
- June 1, 2022, through November 30, 2022, will receive \$2,000.00 gross pay:
- July 1, 2022, through November 30, 2022, will receive \$1,500.00 gross pay;
- August 1, 2022, through November 30, 2022 will receive \$1,000.00 gross pay.
- September 1, 2022, through November 30, 2022, will receive \$500.00 gross pay; and
- October 1, 2022, through November 30, 2022, will not receive premium pay \$0.

ARTICLE 5. Appropriation Ordinance No. 2021-52 the "Annual Budget Ordinance for the Calendar year 2022" is hereby amended and the respective sums shall be paid from the ARPA Revenue Replacement Fund #1006 to the Line Items listed below.



WHEREAS, the Town of Chester, Askansas, is a duly incorporated town pursuant to the laws of the State of Arkansas;

WHEREAS, the need to fund the city government is immediate so that there is no lapse in services to the citizens such as police protection, an emergency exists such that this Resolution should go into effect immediately.
