The Quorum Court of Crawford County, Arkansas met March 13, 2023, for the third regular meeting of the year. The meeting was held at 7:05 p.m. in the Circuit Courtroom I, 300 Main St., Van Buren, Arkansas. Judge Keith presiding. Gentry Wahlmeier, Prosecuting Attorney legal counsel was present. Roll was called. Members present were Justice Atwell, Carolan, Cox, Jennings, Martin, Shaffer, Wahlmeier and Woodruff. Absent was Justice Arnold, Morgan, Myers, Peppas and 1 vacancy of Justice Morrison

The minutes of 2/21/2023 Regular meeting was presented. Justice Cox moved to approve, second by Justice Woodruff and unanimous voice vote to approve as written.

The minutes of the 2/21/2023 Personnel committee was presented. Justice Cox moved to approve, second by Justice Shaffer and unanimous voice vote to approve as written.

donating some are all this property for all to be used to the VFW Post for the veterans and all. The VFW building that we now have we have out grown and would like to see this come about. Mr. Hicks thanked everyone for hearing him out on this project.





BE IT ENACTED BY THE QUORUM COURT OF CRAWFORD COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE AMENDING AND PARTLY RESTATING ORDINANCE 2018-5, SETTING THE PER DIEM REIMBURSEMENT TO A CUMULATIVE AMOUNT; AND FOR OTHER PURPOSES

Whereas, Ordinance 2018-5 amended Ordinance 32-2003.

Whereas, Ordinance 2018-5 sets the per diem reimbursement for meals per day for County employees traveling outside the county in SECTION 2.

NOW THEREFORE, BE IT ORDAINED:

SECTION 1. Ordinance 2018-5, SECTION 2, is amended to read as follows:

SECTION 2. Amends Ordinance 2018-5 to read as follows: When otherwise legally authorized, for County purposes, a County officer or employee of either, traveling outside of Crawford County, Arkansas, on behalf of said County may be reimbursed for the actual cost of meals for travel to include breakfast, lunch, and dinner outside of the county up to the then current State of Arkansas per diem rate. Reimbursement for meals per day will not include breakfast on the day of leaving or dinner on the day returning to the County. Reimbursement requires original legible itemized receipt for such expenditures attached to proper application for reimbursement, and a copy of the agenda which indicates the purpose of travel and a copy of the attendee sign in sheet(s) when applicable. All receipts must be itemized for each individual employee seeking reimbursement. Meal reimbursement is cumulative and not required to track for each individual meal (breakfast, lunch, and dinner) and is a lump sum amount given for each day. Additionally, employees may be reimbursed for lodging at the then current State of Arkansas rate. Lodging may be reimbursed at a rate higher than the current State of Arkansas rate, if the lodging is directly connected to a conference which employee is attending at the request of the elected official for whom he or she works; under this circumstance, employee may be reimbursed at the rate negotiated by the conference. Mileage for official county business, within or out of County, will be reimbursed at the state mileage rate. The County will not reimburse expenses where there is no receipt or if a photocopy of the receipt is provided. The County will not reimburse or pay for spouse expenses. Any expenses over and above the State of Arkansas per diem rate will be the responsibility of the employee. Lost receipts or non-itemized receipts for fuel/meal will not be paid by the County. Employees will be responsible for lost receipts or non-itemized expense receipts. There will be no reimbursement for fuel when mileage per diem rate is collected.

SECTION 2. All other portions of the ordinance shall stay in full force and effect.

SECTION 3. If any provisions of this Ordinance are held invalid, such invalidity shall not affect the other provisions of the ordinance that can be given effect without the invalid provision, and to this end, the provisions of the ordinance are declared to be severable.

SECTION 4. The Quorum Court hereby finds and declares these facts are true and correct as set forth herein.

SECTION 5. This Amendment shall go into effect immediately.
