QUORUM COURT JOURNAL OF PROCEDURES

September 18, 2023

The Quorum Court of Crawford County, Arkansas met September 18, 2023, for the nineth regular meeting of the year. The meeting was held at 7:00 p.m. in Circuit Courtroom I, 300 Main Street, Van Buren, AR. Judge Chris Keith presiding. Gentry Wahlmeier, the Prosecuting Attorney office legal counsel was present. Roll call was called. Members present: Justices Arnold, Atwell, Beauchamp, Carolan, Cox, Jennings, Martin, Morgan, Myers, Peppas, Shaffer, Wahlmeier, Woodruff.

The minutes of 8/21/2023 Regular meeting was presented. Justice Woodruff moved to approve, second by Justice Morgan and unanimous voice vote to approve as written.

The minutes of the 8/29/2023 Special called meeting was presented. Justice Atwell moved to amend the minutes due to typo corrections to the minutes, second by Justice Beauchamp. All in favor of putting it on the floor as amended. Justice Peppas made motion to approve minutes as amended, Justice Morgan second and unanimous voice vote to approve minutes as amended.

The minutes of the 8/21/2023 Budget meeting was presented. Justice Woodruff moved to approve, second by Justice Morgan and unanimous voice vote to approve as written.

REPORTS: Justice Peppas moved to accept reports presented, second by Justice Atwell and unanimous voice vote to approve as submitted.

COMMITTEE REPORTS:

COMMENTS FROM THE PUBLIC: Patron Mandy Steele, spoke regarding an email from one of the Justice of the Peace. Justice Peppas stated this has nothing to do with what is being voted on and Counsel Gentry Wahlmeier gave Mandy permission to speak. She asked that Justice Peppas recuse himself from voting for any Ordinances involving the Crawford County library. She believes it shows a conflict of interest. She offered assistance in helping anyone sign up for training on Awareness on disability etiquette and language.

Patron Mike Rich had signed up to speak but was not present at the time to speak.

Patron Rebecca Virden spoke on email previously discussed. She mentioned the statement "I will credit you for pushing me over the edge", stated that her husband works in mental health and if someone feels they are being pushed over the edge then please seek help.

JUDGES NOTES: (1) The Courthouse remodeling is ongoing. Judge Keith thanked QC for allowing the appropriation for the extra cost of fixing the deteriorating windows. We are on schedule for the work to be finished by the time for the Courthouse lighting. (2) The 911 building is going well. The duct work is in, the stud walls are up on the inside, the electrical and plumbing is going in. (3) Several projects are going on in the road department. We have done a mile of overlay on Hobbtown Road. Working on patches of bad areas on 80 and 81. Still on schedule to do one mile of Westville Rd and Hwy 162. Overlay on Rudy Road should start work in mid-November. (4) The Road Department has purchased a new brush cutter to help with the maintenance during the summertime with mowing. (5) Justice Atwell asked if we were running approximately 1800 miles of County Road. Judge Keith stated it's about 1300 miles.

 by the court, roll call vote, 13 yeas.
- 2. ORDINANCE NO. 2023-29: AN EMERGENCY APPROPRIATION ORDINANCE AMENDING THE BUDGET ORDINANCE NUMBER 2022-80 TO APPROPRIATE ADDITIONAL FUNDS AND APPROVE ADDITIONAL EXPENDITURES TO THE CRAWFORD COUNTY 2023 BUDGET FOR VARIOUS DEPARTMENTS: TRANSFERS AND FOR OTHER PURPOSES. On motion by Justice Shaffer to read by title only as amended in budget meeting, motion by Justice Morgan, second by Justice Peppas, Ordinance 2023-29 was presented by title only as amended. After reading by title only as amended, Justice Peppas moved to approve, second by Justice Woodruff. Justice Atwell asked Ms. Eva White, CCLS Director, what the money concerning the transfers/appropriations for the service contracts was for. Ms. White addressed the Court explaining that the money was not budgeted properly in the previous year, and it was left off the budget at that time. Ms. White stated it was bad communication between the 2 previous directors. The money needed was for the K&S software contract. Justice Jennings asked for things to be more explanatory in letters turned in for transfers and appropriations. Judge Keith stated we can certainly, in the future with all offices, make sure that it is clearer on what the appropriations are needed for. Justice Jennings was inquiring on what the service contract appropriations were for the Sheriff's office. Chief Wiley was present to speak on behalf of the Sheriff's office. He stated he knew that \$20,000.00 of the \$60,000.00 was for a maintenance contract for the air conditioning system in the jail. He was unsure of what the remainder of the appropriation was needed for, but assured he would find out for QC and let them know. Sheriff Perry was not present to answer questions at this time. Justice Atwell wanted to clarify that the money asked for the prisoner food would be enough to last for the remainder of the year. Chief Wiley stated we hope it is enough to last until the end of the year. 12 yeas, 1 no.

ANNOUNCEMENTS: (1) Elaine Stanfield wanted to let everyone know that the Crawford County Fair was a success. (2) The community cleanup starts the upcoming weekend with dumpsters located within each city. (3) Justice Shaffer invited everyone to the American Foundation for Suicide Walk at Creekmore Park in Ft. Smith. Crawford County has the highest rate for suicide in the State of Arkansas and this walk is to raise money in hopes to help those that are contemplating suicide.
