# COMMENTS FROM THE PUBLIC:

JUDGES NOTES: (1) Courthouse remodeling still going on we have got pretty much all the painting done but we are concentrating on the front side so we can get all the Christmas lighting up in time for the courthouse lightning on December 2, 2023. (2) Dispatch Center is still moving forward and had some issues with some subcontractors. They have had to replace some of the subcontractors which caused us some delay. (3) Division III had some issues with HVAC on the routing of it and hoping to get done with it this weekend. They will be without partial air for a few days. Hopefully it will work out. (4) Hwy Dept. – we got the overlays done on Westville Road, and we are starting the widening project on Mays Branch and Freedom Valley which we will start the overlay on next year. Silver Bridge project at Mulberry we are having a little complication in it which at one time Mulberry was going to take it and put it in the park and the city council chose not to. The city of Harrison was going to take the bridge, but they chose not to. There is a lot of history there, but we are going to have to take it down. Still doing a lot of asphalt repairs across the county and drainage upgrade. The overlay on Rudy is still on schedule for mid-November. (5) Still waiting on numbers on insurance for the 2024 Budget.
