**AN EMERGENCY ORDINANCE SETTING A TIME VALUE FOR HOLIDAY PAY:

WHEREAS, the laws, policies and procedures of Crawford County, Arkansas provide that employees may, from time to time, be awarded holiday pay.

WHEREAS, Crawford County has never defined the time value for holiday pay.

WHEREAS, the purpose of this Ordinance is immediately necessary for preservation of the health, safety, and welfare of the inhabitants of Crawford County, Arkansas, and an emergency exists which requires that this Ordinance become immediately effective and of full force and effect, immediately;

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF CRAWFORD COUNTY, ARKANSAS:

SECTION 1. Holiday Pay shall from hereon be given the time value of eight (8) hours despite the time or shift the employee works upon any said set holiday. This value shall apply to all county employees and the Crawford County Employee Handbook shall be amended to add this value.

SECTION 2. Holiday Pay shall be used within forty-five (45) days. This declaration shall also apply to all county employees and the Crawford County Employee Handbook shall be amended to add that Holiday Pay must be used within forty-five (45) days.

SECTION 3. The Quorum Court hereby finds and declares that the facts set out herein are true and correct.

SECTION 4. The various paragraphs hereof and portions hereof being severable, should any part thereof be declared invalid, for any reason, the remainder hereof shall continue in full force and effect.

SECTION 5. EMERGENCY CLAUSE: the ability to maintain certainty and clarity in the scheduled observation of work periods and provision of pay therefore is essential to the public health, safety, and welfare of Crawford County, and the goal can be met by enactment of this ordinance; an emergency is therefore, declared to exist, and this ordinance shall be in full force and effect from and after the date of passage.
