QUORUM COURT JOURNAL OF PROCEDURES  
May 20, 2025

The Quorum Court of Crawford County, Arkansas, met May 20, 2025 for the fifth regular meeting for the year. The meeting was held in Circuit Courtroom 1, 300 Main Street, Van Buren, AR. Judge Chris Keith presiding. Gentry Wahlmeier, the Prosecuting Attorney office legal counsel was present. Roll call was called. Members present: Justices Arnold, Bell, Cole, Johnson, Myers, Peppas, Shaffer, Staton, Stinchomb, Woodruff.

The minutes of 4/21/2025 Regular meeting and minutes for Special called meeting 4/28/2025 was presented. Justice Peppas moved to approve, second by Justice Arnold, a unanimous voice vote to approve as written.

The minutes of the 4/21/2025 Budget meeting and for Special Called meeting 4/28/2025 was presented. Justice Shaffer moved to approve, second by Justice Myers, a unanimous vote to approve as written.

REPORTS: Justice Woodruff moved to approve reports presented, second by Justice Johnson, a unanimous voice vote to approve as presented.

COMMITTEE REPORTS:

COMMENTS FROM THE PUBLIC:

JUDGES NOTES: (1) Judge Keith apologized for having to move the meeting from May 19<sup>th</sup> to May 20<sup>th</sup> due to the weather coming in, but safety was the main concern. Thankfully we did not get damage like some of the surrounding areas did. But to please keep those in your thoughts and prayers. (2) The Road Dept still need to do the shoulders on Oliver Springs Rd and then will get the striping done. Just finished asphalt on Rock Creek. Moving to Mote Rd to get patching done. Forest Green is almost done on the State Aid project on the last couple of miles on 88 road. We received a \$20,000.00 grant from Fire House Subs through Emergency Management and Search and Rescue that will be spent to purchase a raft with a platform, 6 wet suits, 3 dry suits, 6 helmets and accessories. We thank Fire House Subs for giving us that grant. (2) Fire Protection District 6 is up and running. They now have 11 members that have joined and 10 of those are already certified.

CALL FOR OLD BUSINESS: Justice Peppas stated he spoke with someone from the Extension Office before coming into the meeting about damage taken by the County Extension Office building. He asked the court if the gentleman could approach. Judge Keith said yes and asked the gentleman to come forward. Landon Gunnell, staff chair for the Extension Office, approached the Court. When coming into work they had 3 different areas of the office that had water damage that looked like water had come in through the 2 exterior doors in the back. He did use a shop vac to clean up the water and put a fan on it to help dry. There is an additional area in the office that had water damage along the exterior wall. Judge Keith stated we will look at it and come up with a solution to get it fixed.

Justice Johnson wanted to brag on the Dispatch center. They kept a level head through the chaos during the storms. The road dept was out early this morning before 8:00 and checking on roads and Justice Johnson wanted to thank them for job well done. Justice Peppas stated that the road crew was out after 5:00 p.m. also.

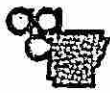
